Subject: Reassigned Numbers Database (RND) - Subscription Tiers/Pricing

Effective on April 27, 2022, the subscription tiers and pricing for querying the Reassigned Numbers Database (RND) will be changing as shown in the table below and posted to <a href="https://www.reassigned.us/">https://www.reassigned.us/</a> under "What's New".

Existing subscriptions will not be affected. The same options will be available if a subscriber to the RND exhausts its queries before the end of the subscription term. Upgrades to a higher tier and "TopOffs," paying ten percent (10%) of the price of the subscription to receive ten percent more queries, will still be available. Please note that Upgrade options will increase to include all the new tiers and prices effective on April 27, 2022.

Further discounts available to Caller Agents for Tiers 6-10 will also become effective April 27, 2022. Please contact the RND Administrator at <a href="mailto:support@reassigned.us">support@reassigned.us</a> or 1-833-763-2366 to determine if you qualify for the Caller Agent Discount and what the discount (ranging from 25% – 40% off the regular pricing) is for each applicable tier. Please note that a Caller Agent is required to have at least one client company and must provide a Letter of Authorization for each client (to be approved by the RND Administrator) in order to query the database as a Caller Agent.
