Subject: Reassigned Numbers Database (RND) - Subscription Pricing

Effective on April 3, 2023, the subscription pricing for querying the Reassigned Numbers Database (RND) will be changing as shown in the table below, and posted to <a href="https://www.reassigned.us/">https://www.reassigned.us/</a> under "What's New".

Existing subscriptions will not be affected. The same options will be available if a subscriber to the RND exhausts its queries before the end of the subscription term. "TopOffs" to pay ten percent (10%) of the price of the subscription to receive ten percent more queries will continue and Upgrading to a higher tier will still be available. Please note that annual subscriptions will also be available starting April 3, 2023.

Caller Agent Discounts will be available for Tiers 6-10 effective April 3, 2023. A Caller Agent is required to have at least one client company in order to query the database. A Caller Agent also must provide a Letter of Authorization for each client to be approved by the RND Administrator.
